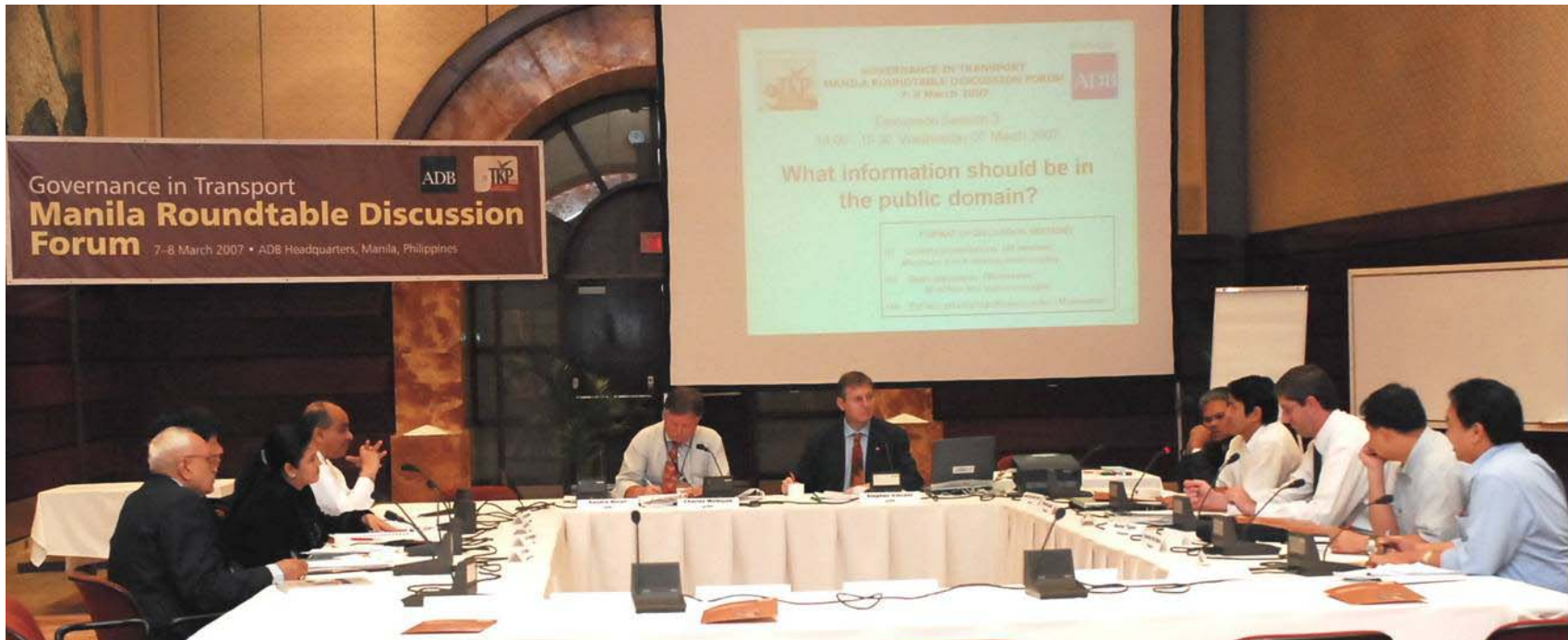

**What are the main governance issues in the transport sector?**

*Results of discussion - 1:*

- Weak planning processes
- Inappropriate political interference
- Lack of long term view – (eg 12 month budget cycle)
- Flawed procurement processes
- Corruption

**What are the main governance issues in the transport sector?**

*Results of discussion - 2:*

- Transparency – being able to see what is really happening
- Inadequate technical skills
- Inadequate contract supervision & poor quality control
- Weak enforcement of laws and regulations (eg overloading)

**What interventions were tried to improve governance in the transport sector, what worked, and what did not work?**

*Results of discussion - 1:*

- Contracting out maintenance (worked – but maybe limit to 5 years)
- Contracting out design and supervision (worked)
- Separate supervising consultant (worked)
- Standard methodologies for project appraisal (worked)
- Effective technical & financial audits (worked)

**What interventions were tried to improve governance in the transport sector, what worked, and what did not work?**

*Results of discussion - 2:*

- Decentralisation (mixed results – perceived good, practical problems)
- Road fund initiatives (delayed implementation, political interference)
- Information made available to stakeholders (positive effect)
- Multi-sectoral involvement (positive effect)

**What information should be in the public domain?**

*Results of discussion - 1:*

- Generally – the more information available the better
- Annual performance report
- Comprehensive details of each current project
- Quality of information important
- Media education - potential misuse of some information
- Benchmarking - between projects & between countries

**What information should be in the public domain?**

- Budget details and road sector plans
- Procurement process details for each project
- Condition of the road network and traffic levels
- Information to support toll levels & road user charges
- But... general lack of response to information made available

**How can civil society be mobilized to improve

*Results of discussion - 1:*

- Take a multi-sectoral approach
  - public, private, civil society, academic, media
- Very few NGOs support governance in transport
- More information could lead to more participation
- Effective protection of whistleblowers

- Media training needed (solutions rather than causing controversy)
- Public education to raise awareness & understand issues
- Each country needs a unique solution
